A. By-law Amendment – 4.1(k) Specific Licence (Eyelash Enhancements)

Amending By-law 4.1 (k) - Specific Licence (Eyelash Enhancements) by adding eyebrows to the Specific Licence (Eyelash Enhancements) to allow Specific Licence (Eyelash Enhancements) to include enhancements to the eyebrows and shaping of the eyebrows by tweezing.

B. By-law Amendment ➤ 4.1 (e) and 4.1 (f) Master Instructor experience/time requirement

Amending By-law 4.1 (e) and (f) - Master Cosmetologist Instructor (Hairdressing) and Master Cosmetologist Instructor (Esthetics) to reduce experience required to apply for Instructor licensure from 5 years to 3 years.

Reducing Master Cosmetologist Instructor (Hairdressing) and Master Cosmetologist Instructor (Esthetics) experience required to apply for designation from 5 years to 3 years, making all instructor requirements equal in time required. Currently Specific Instructor is 3 years, Master Instructor is 5 years.

C. By-law amendment – 4.1 (g) Specific Licence (Salon Assistant) Licence

Amend to allow other Cosmetology skills to be included, not just for hairdressing.

D. Specific Licence Breakdown (previously voted down by Members)

Edit or Addition to By-law 4.1

Body Hair removal licence - currently three hundred (300) hours incudes waxing, sugaring, threading and other introductions for hair removal) – break down further to sugaring only.

or

Approval of a Specific Licence (issued for any one or more skill scopes found under Cosmetology) and a Specific Master Cosmetology Instructor – (issued for any one or more skill scopes found under Cosmetology) Licence
