Maximum Duration: 3 days

A Special Event Mobile Services Permit application must be submitted a minimum of 30 days prior to the subject scheduled event. If an application is not received more than 30 days prior to an event, processing time may be delayed.

A Special Event Mobile Services Permit will only be issued to an active member of the Cosmetology Association of Nova Scotia (member licence number is required.)

Please note: a temporary Special Event Mobile Services Permit is not renewable.
