OLD BUSINESS:

RESCIND - Clinical Motion by Members, approved in October 2019, at AGM.

A Master Cosmetologist (Esthetics) who has been engaged in cosmetology for 2 years or more as a Master Cosmetologist (Esthetics) in a registered cosmetology establishment and who has successfully fulfilled such requirements determined by the Association by policy, and pays the fees required in these By-Laws shall be issued a Master Cosmetologist (Clinical Esthetics) Licence.

Motion by Amy O'Keefe to approve a Specific Master (Clinical Esthetics) Licence; seconded by Sylvia Dalton.

Motion 6 Carried

<u>Reasoning</u>: Committee completed a further review of Clinical esthetics, and those currently providing clinical services, checked other province and country requirements, and considered current esthetic student requirements, current working Estheticians, clinical skills required and the Milady Advanced Esthetics and other textbooks to obtain the curriculum for Clinical Esthetics. Reviewed all current Licence categories and requirements.

Reasoning:

A person who has been engaged as a Cosmetologist (Esthetics) for 6 months or more in a registered cosmetology establishment providing clinical skincare services and who has successfully fulfilled such requirements determined by the Association by policy, and pays the fees required in these by-laws may be issued a Cosmetologist (Clinical Esthetics) Licence.

ii. Master Cosmetologist (Clinical Esthetics)

A person who has been engaged in cosmetology for 3 years or more as a Cosmetologist (Clinical Esthetics) in a registered cosmetology establishment providing clinical skincare services and who has successfully completed a minimum of 4 upgrade courses approved by the Association and fulfilled such requirements determined by the Association by policy, and pays the fees required in these by-laws shall be issued a Master Cosmetologist (Clinical Esthetics) Licence.

iii. Master Cosmetologist Instructor (Clinical Esthetics)

- A person who has been engaged in cosmetology for 2 years or more as a Master Cosmetologist (Clinical Esthetics) in a registered cosmetology establishment providing clinical services and who has successfully fulfilled such requirements determined by the Association by policy, and pays the fees required in these by-laws shall be issued a Master Cosmetologist Instructor (Clinical Esthetics) Licence.
- iv. Clinical fees fees will be the same as comparable Licence categories
 - Clinical Esthetics \$85
 - Master Clinical Esthetics \$90
 - Master Instructor Clinical Esthetics \$95

- b) Specific Licence (Natural Textured Hairstyling)

Reasoning:

- · Requested by Members and the Public
- To ensure Public and Member safety
- To recognize, empower, support, and include unlicensed individuals who excel in specialized hairstylist skill areas and who want to be part of the Association
- To officer a pathway for newcomers to Nova Scotia
- To offer a pathway toward a full Hairstylist Licence with reduced requirements
- To increase speciality services for all individuals in Nova Scotia, no matter what salon they choose
- To continue to be inclusive of all skills and new skills that fall under a hairstylist
- To ensure a professional skillset and professional practices
- To offer additional opportunities for advanced skill training and classes
- To protect salons, spas, Members, and the Industry as a whole

A person who has successfully completed 300 hours of theory and practical instruction as required in the *Act* and these By-laws and who has successfully passed the examination prescribed by these By-Laws and pays the fees required by these By-Laws shall be issued a Specific **Natural Textured Hairstyling** Licence.

This Licence permits the person to perform the services of wigs, weaving, braiding, cornrows, locks, knots, twists and all forms hair extensions and styling by hand or mechanical device; for the purpose of this definition the phrase "natural hair" shall include the use of artificial or natural hair "extensions or enhancements".

OR

➤ The approval of the elimination of all Specific Licenses under the current categories, to be replaced by a **single specific Licence**, limited to one or more practice areas found under the scope of Cosmetology.

Motion to by Cindy Hinde-Saulnier to approve a Specific (Natural Textured Hairstyling) Licence; seconded by Bernadette Taylor.

<u>Reasoning:</u>

- Removed from all previous Acts clarity of the definition is required to ensure all aspects of Cosmetology are included
- To protect the Public from harm
- Cosmetologists are professionals thus all skills falling under the scope of practice
 of a "Cosmetologist" should remain with those who are trained and licensed to
 protect the Public pursuant to the Cosmetology Act (Estheticians, Hairstylists,
 Clinical Estheticians, Eyelash Artists, Nail Technicians, and Body Hair Removal
 Specialists)
- To keep up with an industry that is continually evolving
- Remain inclusive of all competences and new skills that fall under the skillset of a cosmetologist
- To provide additional pathways to obtain cosmetology skill training
- To protect all salons, spas, and the Industry as a whole

Under NEW BUSINESS – NEW considerations 2022

1. Master Specific Licence titles

- Master Specific (skillset) Licence
- Specific Master Instructor (skillset) Licence

Master Instructor Specific (skillset) Licence with upgrade requirement, same as other Master Instructor requirements, except amend **Specific Cosmetology Instructor** to read - **Master Specific Cosmetology Instructor** (3 years required)

Reasoning

- Members' request for similar recognition
- Most professionals have a professional development requirement
- To protect the Public with new updated requirements
- All Masters should be recognized and remain updated in new skills and infection control requirements and processes
- There is currently no recognition for advanced training
- There is currently no Master level under Specific Licence categories
- Specific Cosmetologist are professionals and want to be treated equally as all other Master levels and Master Instructor Licence titles
- 2. Interim Instructor Licence previous Licence removed in 2012.

Reasoning

- Members' and Instructors' request to have this Licence category reinstated to allow individuals who do not have the time required for a full Instructor Licence to be able to work part time to assist instructors
- To allow schools more access to qualified Members
- Members' request to assist in the classroom prior to having the time required for an Instructor's Licence, to gain Instructor experience and mentoring
- 4. Removal of eyelash extensions from the Esthetics and Make-up curriculum.

<u>Reasoning</u>

- Clear program requirements
- Esthetics and Make-up programs were required to offer an intro to eyelash
 extensions only; not enough to have graduates salon/floor ready causing concern
 for Public safety
- · Most current graduates of esthetics do not want to learn or provide this service
- Eyelashes and Make-up are stand-alone programs, both requiring 300-hours of instruction. Eyelash hours cannot be inserted into the Esthetics program without extending the 1500-hour program

• Ensure qualified education and hands-on training of cosmetology graduates

Note: A licensed Esthetician or Make-up Artist providing lash extension services (prior to February 6, 2022), can apply to be grandfathered. The grandfathering period will be from February 7, 2022, to February 6, 2023. Applications can be found on the Association's website.
