

Competitors must choose the competition for their scope of practice, and provide all their own requirements (model, mirror, tools, products, nails, shadow boxes, accommodations etc.;) and are responsible for all costs associated with the competition.

Total Look Details:

Competitors must hold a valid and current Nova Scotia Cosmetology licence to enter. Teams of up to three (3) are accepted; however, the team must have one Hairdresser as well as one Esthetician and/or Makeup Artist. Should an individual wish to enter solo, they must hold a licence in Hairdressing as well as Esthetics and/or Makeup Artistry.

Competitors are required to complete a total, themed look from head-to-toe. They have complete freedom of design to showcase their interpretation of the FEARLESS theme. Movement in color, design, makeup, and attire must be a completed look suiting the model. Hairpieces/ornaments, supports, wefts, and extensions made of hair may be used, but 50% of the natural hair must be visible - open to all hair colors. NOTE: Competitors cannot use any copyrighted art, designs, or logos. No nudity.

On the day of the competition, competitors will complete their total look on-stage applying facial makeup. All other components (hair, props, body paint, nails, costume, etc.,) must be complete prior to taking stage. Entrants will be disqualified if models arrive with facial makeup; the face must be clean with no residue and/or makeup. Competitors must apply facial makeup on-stage within the allotted one-hour time frame. The Cosmetologist on-stage completing the look must hold a current licence in Esthetics or Makeup Artistry.

Judging will be based on originality, visual interest, color, balance, complexity, workmanship, attention to detail, makeup, costume, verall impression, and the entrant's ability to effectively depict the FEARLESS theme.*







Hairstyling and Apprenticeship

The apprenticeship pathway is a two-fold program, which requires an Apprentice to work under a licensed and qualified Hairstylist, as well as attending periods of technical training at the NSCC over a three-year time period.

Participating employers and Apprentices will be eligible for financial incentives that are available through the Federal and Provincial governments.

There are many benefits of an apprenticeship pathway. Listed below are just some of the major bonuses:

- Employers can mentor and train Apprentices throughout the three-year program, all the way to certification
- Apprentices can earn while they learn, and gain real job experience. This makes them a more productive, valuable asset to the employer
- A Skills Logbook is provided to Mentors to help them train Apprentices in the full scope of practice
- Apprentices are trained to a high standard set by the cosmetology industry, so that they may practice safely in the salon environment
- Jobs in the community may allow youth to continue calling Nova Scotia home

- An apprenticeship model may make the occupation a more affordable option for some to pursue as a career
- The partnership between the Cosmetology Association of Nova Scotia and the Nova Scotia Apprenticeship Agency strengthens and enhances Apprentice recruitment as well as employer support along the training pathway




